This matter is before the Chief Procurement Officer for Construction (CPOC) pursuant to a request from Cannon Construction Company (Cannon), under the provisions of §11-35-4210 of the South Carolina Consolidated Procurement Code, for an administrative review on the Industrial Arts, Phase B – Building Renovations bid (“the Project”) for the Tri-County Technical College (Tri-County). Cannon protests Tri-County’s posting of a Notice of Intent to Award stating “No award. No Responsive and Responsible Bidders.” Pursuant to S.C. Code Ann. §11-35-4210(4) (Supp. 2006), the CPOC conducted an administrative review. This decision is based on that review and the applicable law and precedents.

NATURE OF THE PROTEST

A copy of Cannon’s bid is incorporated herein by reference and attached hereto as Exhibit 1.

RELEVANT FACTS

1. Tri-County advertised for bids for the project on September 1, 2011. [Ex. 2]
2. The solicitation required bidders to list on their bid form subcontractors the bidder intended to use on its base bid for the subcontractor specialties of electrical, plumbing, mechanical, and structural framing. [Ex. 3]
2. By the time for receipt of bids, Tri-County received thirteen bids. [Ex. 4]
3. Cannon submitted the apparent low bid. [Ex. 3 & 4]

4. Twelve bidders listed Comfort Systems as their subcontractor for the subcontractor specialty of mechanical.¹ [Ex. 4]
5. The bidders listing Comfort Systems provided a license number for Comfort Systems of M10701². No such license number exists in the database of contractors licensed with the Contractors Licensing Board.
6. After bid opening, Tri-County conducted an investigation concerning the identity of Comfort Systems. Tri-County determined that Comfort Systems is Comfort Systems USA, Inc., an entity that at the time of bidding did not possess a contractor's license. Therefore, Tri-County determined all bidders listing Comfort Systems or Comfort Systems USA to be non-responsible bidders. [Ex. 5 & Ex. B to Ex. 1]
7. On October 3, 2011, Tri-County posted a Notice of Intent to Award declaring there were no responsive and responsible bidders. [Ex. 6]

DISCUSSION

In this solicitation, Tri-County declared twelve bidders to be non-responsible for listing Comfort Systems for the mechanical subcontractor specialty and declared the remaining bidder to be nonresponsive for failing to fully comply with the subcontractor listing requirements. A determination of responsibility is required by S.C. Code Ann. § 11-35-1810, which states “[r]esponsibility of the bidder or offeror shall be ascertained for each contract let by the State.” A procurement officer’s determination of responsibility is final and conclusive unless it is “clearly erroneous, arbitrary, capricious, or contrary to law.” *S.C. Code Ann. § 11-35-2410(A)*. The South Carolina Procurement Review Panel has held that the protestant has the burden of proving that the procurement officer’s determination is “clearly erroneous, arbitrary, capricious, or contrary to law.” *Protest of Brantley Construction Co., Inc.*, Case No. 1999-3.

A responsibility determination is a determination that the bidder has the ability to perform. *See S.C. Code Ann. Regs. 19-445.2125(A)(1)*. Possession of the proper contractor license, either by the bidder or one of the bidder’s listed subcontractors, is an issue of responsibility. *Protest of Brantley Construction Co., Inc.*, 1999-3 (where the State is investigating the bidder’s ability to perform it is deciding an issue of responsibility); *Protest of Roofco, Inc.*, Case No. 2000-14(I) (stating that “the lack of a proper license to do the work solicited in a state contract will always render a bidder nonresponsive.”). If, at the time of

¹ One bidder, Hogan Construction Group, LLC (Hogan), listed SM Lawrence for the subcontractor specialty of mechanical. Hogan’s bid was deemed non-responsive for failure to list any entity for the structural framing specialty.

² A South Carolina license number does not actually have an alphabetical prefix. However, attaching an M prefix to a license with a mechanical classification is a common practice. Throughout the remainder of this document, the CPOC omits the M prefix.

bidding, a subcontractor listed on bidder's bid does not possess the proper license for performing the work for which the subcontractor was listed, then neither the listed subcontractor nor the bidder are responsible bidders. S.C. Code Ann. § 40-11-200(B)³; *See also, Protest of Burkwood Construction Company, Inc.*, Case No. 1997-8 (affirming its prior decisions that the State cannot accept a bid where the low bidder listed a subcontractor who could not perform the work specified by the bid).

While making a responsibility determination for Cannon and Cannon's listed subcontractors, Tri-County ran into a problem with the company Cannon listed for mechanical, Comfort Systems. The license number provided for Comfort Systems was not valid. While this would normally be a minor informality, there was some question as to the identity of Comfort Systems because the names of several entities licensed with the State included the words "Comfort Systems" in the name. To confirm whom the company listed as Comfort Systems was, Tri-County contacted Cannon and requested a copy of Comfort Systems' sub-bid. [Ex. 5] Cannon provided a copy of Comfort Systems sub-bid which identified Comfort Systems as a company named Comfort Systems USA with an Asheville, North Carolina address. [Ex. 7] The South Carolina license number on Comfort Systems USA's bid was 10701, a number that was not a South Carolina issued license number. [Ex. 5]

Upon reviewing Comfort Systems USA's sub-bid, Tri-County contacted Danny Dillow, the individual preparing the bid on behalf of Comfort Systems USA, to determine Comfort Systems USA's South Carolina license number. [Ex. 5] Mr. Dillow informed Tri-County that there was a typographical error on Comfort Systems USA's sub-bid and the license number should have been 107071. Tri-County checked this number against Labor, Licensing and Regulation's (LLR) website and determined that the license number 107071 belonged to SM Lawrence Company of Jackson, Tennessee, not Comfort Systems USA. Tri-County contacted Mr. Dillow once again and asked who prepared the bid and where the job would be run from. [Ex. 5] Mr. Dillow confirmed that Comfort Systems had prepared the bid in its Asheville, North Carolina, office and intended to run the job out of that same office. [Ex. 5] On behalf of Tri-County, Jim McVey, the Office of State Engineer project manager, contacted LLR regarding the sub-bid of Comfort Systems USA. [Ex. 5] LLR advised Mr. McVey that a bid can only be offered by an entity named on the license, not another entity. [Ex. 8] Based on the foregoing, Tri-County found all bidders listing Comfort Systems or Comfort Systems USA to be non-responsible bidders.

³ This Section reads "[i]t is a violation of this chapter for an awarding authority, owner, contractor...to consider a bid, sign a contract, or allow a contractor to begin work unless the bidder or contractor has first obtained the licenses required by this chapter. Bids or contracts submitted by contractors may not be reconsidered or resubmitted to an awarding authority, contractor, or owner if the contractor was not properly licensed at the time the initial bid or contract was submitted."

Despite the fact that Comfort Systems USA was not licensed at the time of bidding, Cannon alleges in its letter of protest that it did list a properly licensed mechanical subcontractor and, at most, its bid contained a mere clerical error relating to its mechanical subcontractor. Specifically, Cannon argues that in South Carolina, Comfort Systems USA is SM Lawrence.⁴ In support of this contention, Cannon submitted a letter from Comfort Systems USA's Vice President and General Counsel, Trent McKenna, wherein he claims SM Lawrence is a wholly owned subsidiary of Comfort Systems USA.⁵ [Ex. D to Ex. 1] However, a parent company and its subsidiaries are separate legal entities. *See Matter of Trandes Corp.*, B-271662, 1996 WL 433992 (Comp. Gen. Aug. 2, 1996)(holding that two entities were separate and distinct legal entities from one another when they were separately incorporated); *See also, Protest of ACMG, Inc.*, Case No. 1990-4 (finding that parent corporation licensed in South Carolina had no standing to protest a bid submitted by its wholly owned subsidiary because they were two distinct corporations even where they behaved as alter egos). SM Lawrence is incorporated in Madison County, Tennessee, while Comfort Systems USA is incorporated in Delaware. [Ex(s). 9 & 10] The law provides that "[n]o entity or individual may practice as a contractor by performing or offering to perform contracting work...without a license issued in accordance with this chapter." *SC Code Ann § 40-11-30*. Comfort Systems USA, the entity named on the bid, is a separate legal entity from SM Lawrence and is not licensed in South Carolina and cannot bid work in South Carolina.

Despite the fact that SC Code Ann § 40-11-370(B) prohibits a licensed contractor from bidding in a name other than the one appearing on its license, Cannon contends and the letter prepared by Mr. McKenna claims, SM Lawrence prepared the mechanical sub-bid but inadvertently submitted it in the name of Comfort Systems USA. [Ex. D to Ex. 1] Cannon also contends that the South Carolina license number on the sub-bid is clearly associated with SM Lawrence indicating SM Lawrence prepared and submitted the sub-bid. However, an examination of the sub-bid supports Tri-County's conclusion to the contrary. The sub-bid submitted in the name of Comfort Systems USA is devoid of any reference to SM Lawrence. SM Lawrence's name and license number do not appear on the sub-bid. Moreover, the sub-bid provides a Tennessee license number, a Virginia license number, and a North Carolina License, each associated with a company named Comfort Systems USA (Bristol), Inc., not SM Lawrence. [Ex. 7 & 11] Comfort Systems USA (Bristol) Inc., is a Bristol, Virginia based company registered with the South Carolina Secretary of State as a foreign corporation doing business in South Carolina, but is not a licensed

contractor in South Carolina.⁶ [Ex. 12] Moreover, Comfort Systems USA (Bristol) is a corporation formed in Delaware and is a separate and distinct entity from SM Lawrence.

The solicitation required bidders to list specified subcontractors pursuant to SC Code Ann § 11-35-3020(b)(i). The purpose of this statute is to prevent bid shopping and bid peddling of subcontracts after bid opening. *Ray Bell Construction Company, Inc. v. The School District of Greenville County* 331 S.C. 19, 501 S.E.2d 725 (1998) (finding the overall purpose behind Section 11-35-3020 was to prevent contractors from bid shopping and that the failure to comply with bid listing statutes is material and non-waivable); *see also, Protest of Burkwood Construction Company, Inc.*, Case No. 1997-8 (finding that contractor could not substitute another subcontractor for the unlicensed subcontractor it had listed on its bid form because 11-35-3020's purpose was to prevent contractors from substituting subcontractors at the last minute, which thereby enables bid shopping). The subcontractor listing provisions must be interpreted and applied in a manner consistent with this goal. A listing that permits a choice after bidding violates the requirements of this law. Having listed Comfort Systems USA for the subcontractor specialty of mechanical, Cannon must use Comfort Systems USA for this work, not a subsidiary. Comfort Systems USA is not a licensed contractor in South Carolina; therefore, Comfort Systems cannot perform or offer to perform mechanical work in South Carolina. In other words, Comfort Systems USA cannot rely on the fact that one or more of its subsidiaries is licensed in South Carolina to cure its own deficiency.

As previously stated, the sub-bid that Cannon relied on for the subcontractor specialty indicates that it was submitted by Comfort Systems USA, not SM Lawrence. Cannon listed "Comfort Systems," not SM Lawrence, in the space on its bid form for listing the subcontractor for the subcontractor specialty of mechanical. The documentation and the results of Tri-County's investigation support its conclusion that the subcontractor listed on Cannon's bid for the subcontractor specialty of mechanical was Comfort Systems USA, not any other entity. Comfort Systems USA is not a licensed mechanical contractor in South Carolina and, therefore, is not a responsible mechanical contractor. Accordingly, Tri-County's determination of non-responsibility was not "clearly erroneous, arbitrary, capricious, or contrary to law." *S.C. Code Ann. § 11-35-2410(A)*.

⁶ In addition to those already named, a number of other entities associated with Comfort Systems USA are registered with the Secretary of State as foreign corporations doing business in the state. [Ex. 14] However, out of the subsidiaries registered with the Secretary of State, only SM Lawrence and Comfort Systems USA Carolina are South Carolina licensed contractors.

DETERMINATION

Tri-County's determination to reject Cannon's bid on the grounds that the subcontractor listed for the mechanical work, Comfort Systems USA, was not a licensed contractor and therefore was non-responsible was not clearly "clearly erroneous, arbitrary, capricious, or contrary to law."

For the forgoing reasons, the protest is denied.

STATEMENT OF RIGHT TO FURTHER ADMINISTRATIVE REVIEW

Protest Appeal Notice (Revised October 2010)

The South Carolina Procurement Code, in Section 11-35-4210, subsection 6, states:

(6) Finality of Decision. A decision pursuant to subsection (4) is final and conclusive, unless fraudulent or unless a person adversely affected by the decision requests a further administrative review by the Procurement Review Panel pursuant to Section 11-35-4410(1) within ten days of posting of the decision in accordance with subsection (5). The request for review must be directed to the appropriate chief procurement officer, who shall forward the request to the panel or to the Procurement Review Panel, and must be in writing, setting forth the reasons for disagreement with the decision of the appropriate chief procurement officer. The person also may request a hearing before the Procurement Review Panel. The appropriate chief procurement officer and an affected governmental body shall have the opportunity to participate fully in a later review or appeal, administrative or judicial.

FILE BY CLOSE OF BUSINESS: Appeals must be filed by 5:00 PM, the close of business. *Protest of Palmetto Unilect, LLC*, Case No. 2004-6 (dismissing as untimely an appeal emailed prior to 5:00 PM but not received until after 5:00 PM); *Appeal of Pee Dee Regional Transportation Services, et al.*, Case No. 2007-1 (dismissing as untimely an appeal faxed to the CPO at 6:59 PM).

FILING FEE: Pursuant to Proviso 83.1 of the 2010 General Appropriations Act, "[r]equests for administrative review before the South Carolina Procurement Review Panel shall be accompanied by a filing fee of two hundred and fifty dollars (\$250.00), payable to the SC Procurement Review Panel. The panel is authorized to charge the party requesting an administrative review under the South Carolina Code Sections 11-35-4210(6), 11-35-4220(5), 11-35-4230(6) and/or 11-35-4410...Withdrawal of an appeal will result in the filing fee being forfeited to the panel. If a party desiring to file an appeal is unable to pay the filing fee because of hardship, the party shall submit a notarized affidavit to such effect. If after reviewing the affidavit the panel determines that such hardship exists, the filing fee shall be waived." 2010 S.C. Act No. 291, Part IB, § 83.1. PLEASE MAKE YOUR CHECK PAYABLE TO THE "SC PROCUREMENT REVIEW PANEL."

LEGAL REPRESENTATION: In order to prosecute an appeal before the Panel, a business must retain a lawyer. Failure to obtain counsel will result in dismissal of your appeal. *Protest of Lighting Services*, Case No. 2002-10 (Proc. Rev. Panel Nov. 6, 2002) and *Protest of The Kardon Corporation*, Case No. 2002-13 (Proc. Rev. Panel Jan. 31, 2003).

Dear State Engineer:

This is to advise that Cannon Construction Company (“Cannon”), the low bidder on the above-referenced project, hereby protests the decision of Kristal Doherty, CPPO, Purchasing Manager for Tri-County Technical College, with respect to her determination that Cannon’s bid was “non-responsible.” The subject of this protest is the letter dated September 30, 2011, disqualifying Cannon as the low bidder for the project. See Exhibit A. This protest is submitted pursuant to Section 9.5 - Protest of Solicitation or Award. Cannon’s bid contained only a clerical error relating to its mechanical contractor. In short, Cannon did submit a properly licensed mechanical subcontractor, and its bid was both responsible and responsive. The basis of this protest is set forth below.

Tri-County Technical College, ITC, issued a request for bids for the ITC Phase B Building Renovations located at 5321 Highway 76, Pendleton, South Carolina. See Exhibit B. Cannon Construction Company, along with fourteen others, submitted bids for the project that were opened on September 27, 2011. All bids were deemed non-responsive or non-responsible. Fourteen of the bids were deemed non-responsible due to a clerical error by the mechanical subcontractor creating the appearance it was “not a licensed entity.” Cannon’s bid was among those fourteen. Each of those fourteen contractors received a mechanical bid on Comfort Systems, USA letterhead, attached hereto as **Exhibit C**, with a contractor license number associated with the name S.M. Lawrence Company, a wholly owned subsidiary of Comfort Systems, USA, and a company that does business as Comfort Systems, USA.


In South Carolina, Comfort Systems, USA is S.M. Lawrence Company. See **Exhibit D** and **Exhibit E**. It appears this created some confusion in the bid review process, and caused Ms. Doherty to deem the bid non-responsible. Comfort Systems, USA is large national mechanical contracting firm, with more than eighty (80) individual subsidiaries. In South Carolina, it has at least two subsidiaries, including Comfort Systems USA, Carolinas, and S.M. Lawrence Company. When S.M. Lawrence submitted its bid to the various contractors, it did so on its corporate owner's (Comfort Systems, USA) letterhead. **Exhibit C**. As a result, Cannon Construction Company, along with fourteen (14) other bidders, designated Comfort Systems as the name of the mechanical contractor, while the license number provided was associated with the name S.M. Lawrence. As demonstrated above, S.M. Lawrence is Comfort Systems, USA, and, therefore, Cannon's bid was responsible.

This was only a scrivener's error, and this simple error is easily correctable. It would not prejudice any bidder. As seen on the spreadsheet attached hereto as **Exhibit F**, all fifteen of the bidders received the same bid, and fourteen of the bidders identified the mechanical subcontractor as Comfort Systems. The fifteenth identified the subcontractor as S.M. Lawrence, but used the same bid as the fourteen others. In circumstances such as this, the bid should be awarded to the low bidder by granting the protest or allowing Cannon to amend its bid to show the proper name and license number for the Comfort Systems subsidiary performing the work. This result is beneficial to the agency as well, as it would avoid the costs and time associated with a re-bid.

When no unfair advantage is given to a bidder, the bidder should be provided the opportunity to do the work at the low bid price. See Martin Engineering, Inc. v. Lexington County School District One and Sharp Construction Company of Sumter, Inc., Respondents, 365 S.C.1; 615 S.E.2d 110 (2005). Cannon's bid should be reinstated as responsible, and the project should be awarded to Cannon as the low bidder.

It is also a fully licensed South Carolina mechanical contractor. Both SM Lawrence and Comfort Systems USA Carolinas are licensed to perform the work called for in the bid documents. The submission of the bid by Comfort Systems USA may have caused some confusion because Comfort Systems USA Carolinas is also a licensed South Carolina mechanical contractor. 





On behalf of TCTC, Jim McVey of the Office of State Engineer contacted Gary Wiggins of the South Carolina Department of Labor, Licensing and Regulation who determined that a bid can only be offered by the entity named on the license, see attached. Comfort Systems is not the licensed entity and did not have the right to offer a bid. Per regulation 19-445.2125 A (4), TCTC has determined Cannon Construction Company, Momentum Construction Services, Matrix Construction Company and Creative Builders, J. Davis Construction, Yeargin Potter Shackelford Construction, Melloul-Blamey Construction, Lazer Construction, M.L. Garrett Const., Sherman Construction, Hatfield Builders, Town & Country to be non-responsible in their bid submitted for this project.
